# **MEETING RECORD OF DECEMBER 4, 2019**

## 1. CALL TO ORDER AND INTRODUCTIONS

Leslie Bruce (RRC), Co-Chair of the TGPC GWI Subcommittee, called the meeting to order at approximately 9:36 AM CST. GWI Subcommittee members were introduced. The representatives from Texas A&M AgriLife Research (AgriLife Research), Bureau of Economic Geology of The University of Texas at Austin (UTBEG), United States Geological Survey (USGS), and Texas A&M AgriLife Extension Service (AgriLife Extension) were not present at the meeting.

## 2. STATUS REPORTS

Agricultural Chemicals Task Force

Alan Cherepon (TCEQ) reported on the Agricultural Chemicals Task Force:

- The proposed Fiscal Year (FY) 2020 Pesticide Monitoring Plan would be limited to the Cooperative Pesticide Monitoring Program due to ongoing grant budget reductions by the U.S. Environmental Protection Agency (EPA);
- The update and quality assurance and control activities on the TCEQ Interagency Pesticide Database (IPD) had been completed for all 2019 groundwater monitoring samples from TCEQ, the Cooperative Pesticide Monitoring Program, and the USGS, and it was sent to the U.S. EPA in October 2019;
- TCEQ staff would be providing a table-top exhibit at the 31st Annual Texas Plant Protection Association (TPPA) Conference in Bryan/College Station on December 10-11, 2019;
- The Pesticides of INterest Tracking System (POINTS) Pesticide Assessment Database was updated in November 2019 for FY 2019; and,
- Because it would not be covering water quality items, Alan Cherepon (TCEQ) did not attend the biannual U.S. EPA/States/Tribes pesticide meeting in Dallas on October 16-17, 2019, but he planned to attend the next meeting in the spring of 2020, and this meeting should be held in Texas.

David Villarreal (TDA) reported that the U.S. EPA was not funding water projects at their agency, and while pesticides were not the current focus, other water contaminates (e.g., per- and polyfluoroalkyl substances (PFAS), microbes, and lead) were being addressed.

#### **TGPC Publications**

Abiy Berehe (TCEQ) reported on the following TGPC publications:

- Groundwater Assessment for the 2020 Texas Integrated Report for Clean Water Act Sections 305(b) and 303(d) ("Texas Integrated Report", N/A):
  - o Preparation of the groundwater assessment portion of the 2020 Texas Integrated Report had begun and staff planned to complete the report by April 1, 2020.
- Joint Groundwater Monitoring and Contamination Report 2019 ("Joint Report", SFR-056):
  - Staff would start the preparation of the 2019 *Joint Report* in early January 2020.

- Activities and Recommendations of the Texas Groundwater Protection Committee: Report to the 87th Legislature ("Legislative Report", SFR-047)
  - o The TGPC Legislative Report Subcommittee, which is in charge of preparing the *Legislative Report*, would be reactivated at TGPC meeting on January 15, 2020, and preparation of the report would commence thereafter.

# 4. DISCUSS CURRENT GROUNDWATER ISSUES

# **Hydraulic Fracturing**

Leslie Bruce (RRC) reviewed the San Antonio Business Journal handout regarding the plugging of 1,700 abandoned oil and gas wells in FY 2019. The \$34.9 million spent on plugging these wells came from industry permitting and regulatory fees.

Evelyn Reátegui-Zirena (DSHS) left at approximately 9:59 AM CST and returned at approximately 10:01 AM CST.

#### Oil and Gas Produced Water

Leslie Bruce (RRC) presented the Texas Alliance of Energy Producers report titled, *Sustainable Produced Water Policy, Regulatory Framework, and Management in the Texas Oil and Gas Industry: 2019 and Beyond.* The paper "highlights produced water management trends, provides examples of recycle and reuse, explores the evolving regulatory and policy framework in Texas, and provides a fact-based analysis of the impediments to improving produced water management." Ten recommendations for the sustainable use of produced water, including its use outside of the oil and gas industry, were provided.

# **Emerging Contaminants**

Kathy McCormack (TCEQ) presented a TCEQ e-clip titled, *Groundwater contamination found at local Air Force bases*. This article listed the highest level of perfluorooctanoic sulfonate (PFOS) found at three Texas locations: Lackland Air Force Base (250,000 parts per trillion), Kelly AFB (142,000 ppt), and Randolph AFB (120,000 ppt). The U.S. EPA drinking water health advisory is 70 ppt for PFOS/PFOA (perfluorooctanoic acid).

Evelyn Reátegui-Zirena (DSHS) added that they were working with the U.S. Navy on two sites in Texas (one in Fort Worth, and one in Corpus Christi).

Aquifer Storage and Recovery (ASR)

Discussion of this topic occurred during the Business portion of the meeting.

### Abandoned Water Wells

Kathy McCormack (TCEQ) presented a recent online article regarding abandoned water wells in Nacogdoches County. The article encouraged landowners to address this threat to public health by returning the well to an operable state, capping it for future use, or plugging it.

Leah Martinsson (TAGD) reported that they were collecting data on the various cost share plugging programs provided by their members.

Abiy Berehe (TCEQ) added that the Legislature had been interested in funding a statewide abandoned water well plugging program during the last session.

T.J. Helton (TSSWCB) left at approximately 10:10 AM CST, returned at approximately 10:14 AM CST, and was present for the remainder of the meeting.

Wellhead Impacts After Natural Disasters

Kathy McCormack (TCEQ) shared information about the proposed white paper regarding Wellhead Impacts After Natural Disasters. In an email before the meeting, Diane Boellstorff (AgriLife Extension) indicated that they would have talking points available for the next meeting, and that the white paper would focus on the steps that Texas state agencies could take to facilitate data availability and transfer during the next hurricane event.

#### **Brackish Groundwater**

Leah Martinsson (TAGD) reported that the interim charges for the Texas House Committee on Natural Resources included monitoring the progress of House Bill 722 (passed by the 86th Legislature) which was related to the development of brackish groundwater.

Natalie Ballew (TWDB) added that they would be giving a presentation on brackish groundwater at the next TGPC meeting on January 15, 2020.

#### Desalination

There was no discussion of this topic at the meeting.

## **Endangered Species**

Kimberly Horndeski (TPWD) reported on the status of several Texas freshwater mussels:

- Smooth Pimpleback, Golden Orb (Johnson et al. 2018), and Triangle Pigtoe (Pieri et al. 2018) were proposed to be removed from the candidate lists (state and federal) as they were no longer valid species (due to "lumping");
- Guadalupe Orb was recently split from Texas Pimpleback and was proposed to be added to the state-threatened list (Burlakova et al. 2018);
- Guadalupe Fatmucket was recently split from Texas Fatmucket and was proposed to be added to the state-threatened list (Inoue et al. 2019);

- Trinity Pigtoe was recently split from Texas Pigtoe and was proposed to be added to the state-threatened list (Pieri et al. 2018); and,
- Brazos Heelsplitter was recently split from Pink Papershell and was proposed to be added to the state-threatened list (Smith et al. 2019).

Coal Ash from Power Plants

There was no discussion of this topic at the meeting.

Anthropogenic Mixing of Groundwater

There was no discussion of this topic at the meeting.
