Subcommittee Purpose

Pursuant to §26.405 of the Texas Water Code, the Legislative Report Subcommittee is charged to facilitate the TGPC's efforts in publishing the biennial legislative report. Statute requires that the report cover the TGPC's activities for the preceding two years and include any recommendations for groundwater protection legislation. The Legislative Report Subcommittee is charged to:

- Review the previous report's content and revise the scope of the draft report as needed; and,
- Develop, prior to the TGPC's FY08 Fourth Quarter Meeting, groundwater protection legislation recommendations to the 81st Texas Legislature.

Expected Results

The final report, published and distributed prior to December 31, 2008.
